NYC CHARTER SCHOOLS DATA SERVICES AGREEMENT AUTHORIZATION

The NYC Charter Schools Data Services Agreement, annexed hereto, is approved as of the date of execution of this authorization by The Board of Cooperative Educational Services, First Supervisory District of Suffolk County, having its principal place of business at 201 Sunrise Highway, Patchogue, New York 11772, for the sole and exclusive purpose of agreeing to provide data processing services, in accordance with New York State Education Law §1950.4.h.(4), directly to any of the licensed charter schools in the jurisdiction of the City of New York which has been granted authority to operate under the New York State Charter Schools Act of 1998. A list of eligible charter schools is attached hereto as Exhibit 1 (NYC Charter School: 2023 - 2024 school year). The NYC Charter Schools Data Services Agreement shall be binding with any charter school which acknowledges acceptance to the terms and conditions of the NYC Charter Schools Data Services Agreement by their execution of a copy of an Agreement, a blank copy of which is attached hereto, countersigned and acknowledged by the Eastern Suffolk BOCES Director of the Regional Information Center or the Associate Superintendent for Educational Services. The Board authorizes the Director of the Regional Information Center or in their absence the Associate Superintendent of Educational Services to execute the NYC Charter Schools Data Services Agreement with any licensed charter school listed on Exhibit 1. Upon execution by both a properly licensed charter school located in the City of New York and the Eastern Suffolk BOCES Director of Regional Information Center, or in their absence the Associate Superintendent of Educational Services, the Agreement shall be binding upon both Eastern Suffolk BOCES and the individual charter school.

Upon execution below, this NYC Charter Schools Data Services Agreement Authorization shall be valid as of the date of execution and shall remain valid until June 30, 2024. This NYC Charter Schools Data Services Agreement Authorization may be renewed at any interval shorter than one (1) year to accommodate any amendment to the terms and conditions provided herein. Any renewal executed prior to the expiration of the term shall be effective as of July 1 of the renewal year.

Execution of the Agreement by any participating eligible NYC charter school is an acknowledgment of this authorization and acceptance of a copy of this authorization in place of an original.

NYC CHARTER SCHOOLS DATA SERVICES AGREEMENT

WHEREAS, the Board of Cooperative Educational Services, First Supervisory District of Suffolk County ("ESBOCES") is a municipal corporation with authority under Section 1950 of the New York Education Law to enter into, and enforce, contracts, and to provide cooperative educational services to school districts in New York State and/or other educational institutions (such institutions that elect to receive the Services) pursuant to cooperative educational service agreements ("CoSers") approved by the New York State Education Department; and

WHEREAS, licensed charter schools in the jurisdiction of the City of New York have requested and ESBOCES wishes to make available to such schools, upon the terms and conditions set forth herein, data processing services as described in the description of services and price schedule ("Schedule B, Description of Services and Fee Schedule" or "Schedule B"); and

WHEREAS, ESBOCES has authorized the Director of the Regional Information Center ("RIC") for ESBOCES, or the Associate Superintendent for Educational Services, to execute this NYC Charter Schools Data Services Agreement (the "Agreement") with any of the licensed charter schools in the jurisdiction of the City of New York which acknowledges participation by executing this Agreement; and

WHEREAS, the charter school which is agreeing to the terms and conditions by executing this Agreement shall be a licensed charter school located in the City of New York and shall hereinafter be referred to as the Participating Charter School ("Participating Charter School"); and

WHEREAS, Participating Charter School is an educational institution with reporting requirements to the New York State Education Department in accordance with 8 NYCRR §119.3 and Article 56 of the Education Law of New York;

NOW, THEREFORE, for and in consideration of the terms and conditions hereinafter stated, it is agreed as follows:

A. <u>AGREEMENT:</u>

This Agreement shall consist of the:

- NYC Charter Schools Data Services Agreement Authorization.
- NYC Charter Schools Data Services Agreement.
- Schedule A, Contact Information.
- Schedule B, Description of Services and Fee Schedule.

B. <u>TERM:</u>

The term of this Agreement shall be from the date of execution of this Agreement through June 30, 2024, unless terminated earlier as provided for in this Agreement. This Agreement may be extended for renewal terms of one (1) year or less, (each a "Renewal Term"), by mutual written agreement by both parties. Any renewal executed prior to the expiration of the term shall be effective as of

July 1 of the renewal year. It is understood that ESBOCES is under no obligation to renew this Agreement upon its expiration.

C. SERVICES AND RESPONSIBILITIES:

- 1. During the term of this Agreement, the data processing support services available to each Participating Charter School to be provided by ESBOCES shall include the services (the "Services) as described in Schedule B, a copy of which is attached hereto. Each Participating Charter School shall indicate which Services(s) it intends to purchase by utilizing an invoice in accordance with Section F herein.
- 2. ESBOCES shall perform all services under this Agreement in accordance with all applicable Federal, State and local laws, rules, and regulations, as well as established policy guidance from the New York State Education Department.
- 3. Services provided pursuant to this Agreement shall be provided without regard to race, creed, color, military status, sex, sexual orientation, gender, gender identity or expression, national origin, religion, age, disability, predisposing genetic characteristics or marital status or any other basis prohibited by law.
- 4. ESBOCES shall provide all services pursuant to this Agreement in a competent, professional, and timely manner.
- 5. Both parties, their employees, and/or agents agree that all information obtained in connection with the services performed pursuant to this Agreement is deemed confidential information. Both parties, their employees, and/or agents shall not use, publish, discuss, disclose or communicate the contents of such information, directly or indirectly with thirdparties, except as provided for in this Agreement. Both parties further agree that any information received by either party's employees and/or agents in connection with this Agreement which concerns the personal, financial, or other affairs of the parties, their employees, agents, and/or students will be treated as confidential and will not be revealed to any other persons, firms, organizations, or third-parties, except as required by applicable law. In addition, both parties agree that information concerning any student covered by the terms of this Agreement shall not be released except as provided for by applicable law, rule, or regulation, including, but not limited to, the Family Educational Rights and Privacy Act ("FERPA"), and New York Education Law §2-d. Since both parties are either a school or educational agency as defined in 8 NYCRR §121.1, no Education Law Section 2-d -Rider is needed for this Agreement.

In the event of a breach of the within confidentiality provision, either party shall notify the other in the most expedient way possible and without unreasonable delay but no more than seven (7) calendar days after the discovery of such breach, and advise as to the nature of the breach and the steps to be taken to minimize said breach. Both parties shall, to the extent required by any applicable New York State law, indemnify and hold each other harmless from any claims arising from its breach of the within confidentiality provision. The parties further agree that the terms and conditions set forth herein shall survive the expiration and/or termination of this Agreement.

D. INSURANCE:

- 1. Each party, at its sole expense, shall procure and maintain such policies of commercial general liability, as shall be necessary to insure against any claim for a breach in data or any claim that may arise from the performance of data processing services pursuant to the Agreement; each such policy shall provide a minimum coverage of One Million Dollars (\$1,000,000.00) per occurrence subject to an annual aggregate of Two Million Dollars (\$2,000,000.00).
- 2. Each party acknowledges that failure to obtain such insurance may be deemed a material breach of this Agreement.

E. WARRANTY and LIMITATIONS:

EXCEPT AS SET FORTH IN THIS SECTION, ESBOCES EXPRESSLY DISCLAIMS ANY AND ALL REPRESENTATIONS, WARRANTIES AND CONDITIONS OF ANY KIND OR NATURE, EXPRESS OR IMPLIED AND THOSE ARISING BY STATUTE OR OTHERWISE IN LAW OR FROM A COURSE OF DEALING OR USE OF TRADE.

OTHER THAN THAT WHICH IS SPECIFIED IN THIS AGREEMENT AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL ESBOCES BE LIABLE TO PARTICIPATING CHARTER SCHOOL FOR ANY INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING, BUT NOT LIMITED TO DAMAGES FOR LOST PROFITS, OR LOSS OF BUSINESS ARISING OUT OF OR RELATED TO THIS AGREEMENT OR THE PERFORMANCE OR BREACH THEREOF, EVEN IF ESBOCES HAS BEEN ADVISED OF THE POSSIBILITY THEREOF.

OTHER THAN THAT WHICH IS SPECIFIED IN THIS AGREEMENT AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL PARTICPATING CHARTER SCHOOL BE LIABLE TO ESBOCES FOR ANY INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING BUT NOT LIMITED TO DAMAGES FOR LOST PROFITS OR LOSS OF BUSINESS ARISING OUT OF OR RELATED TO THIS AGREEMENT OR THE PERFORMANCE OR BREACH THEREOF, EVEN IF PARTICIPATING CHARTER SCHOOL HAS BEEN ADVISED OF THE POSSIBILITY THEREOF.

F. COMPENSATION:

- 1. Participating Charter School shall pay ESBOCES in accordance with the fee schedule ("Fee Schedule") as described in Schedule B, a copy of which is attached hereto.
- 2. Invoice(s) will be sent directly to the Participating Charter School to the address and contact as provided in Schedule A unless Participating Charter School indicates another method of delivery in writing to ESBOCES. Participating Charter School shall pay ESBOCES within thirty (30) days of the ESBOCES' receipt of such invoice.
- 3. Participating Charter School shall give ESBOCES notice of any invoice disputes within thirty (30) days of its receipt of the invoice.

4. Neither ESBOCES nor any of its personnel shall share or accept any fee or gratuity for services provided pursuant to this Agreement except as expressly set forth in this Agreement.

G. MISCELLANEOUS:

1. Termination:

- a. Either party may terminate this Agreement, with or without cause, for any reason, at any time, by providing ten (10) days written notice to the other party. Such notice shall be given in accordance with the requirements for all notices pursuant to this Agreement set forth below.
- b. The parties agree that either party's failure to comply with any terms or conditions of this Agreement will provide a basis for either party to immediately terminate this Agreement without any further liability.
- c. In the event either party terminates this Agreement with or without cause, such termination of the Agreement shall not discharge the parties' existing obligations to each other as of the effective date of termination.

2. Defense / Indemnification:

To the fullest extent permitted by law, each party agrees to defend, indemnify and hold harmless the other party, its Board of Education, officers, directors, agents, or employees against all claims, demands, actions, lawsuits, costs, damages and expenses, including attorneys' fees, judgments, fines and amounts arising from any willful act, omission, error, recklessness or negligence of either party, its officers, directors, agents or employees in connection with the performance of the Services pursuant to this Agreement. The obligations pursuant to this provision shall survive the termination of this Agreement.

3. Notices

All notices which are required or permitted under this Agreement shall be in writing, and shall be deemed to have been given if delivered personally or sent by registered or certified mail, addressed as follows:

4. It is expressly understood that this Agreement shall not be assigned or transferred without prior written consent of the other party.

- 5. The failure of either party to enforce any provision of this Agreement shall not be construed as a waiver or limitation of that party's right to subsequently enforce every provision of this Agreement.
- 6. ESBOCES shall not be liable to Participating Charter School for any delay or failure to perform, which delay or failure is due to causes or circumstances beyond its control, including, without limitation, the actions of ESBOCES, national emergencies, fire, flood, inclement weather, epidemics, or catastrophe, acts of God, governmental authorities, or parties not under the control of ESBOCES, insurrection, war, riots, or failure of transportation, communication, power supply or pandemic. ESBOCES shall exercise commercially reasonable efforts to mitigate the extent of the excusable delay or failure and its adverse consequences; provided, however, that should any such delay or failure continue for more than sixty (60) days, the Agreement may be terminated by either the party upon notice to the other.
- 7. Should any provision of this Agreement, for any reason, be declared invalid and/or unenforceable, such decision shall not affect the validity of the remaining provisions of this Agreement. Such remaining provisions shall remain in full force and effect as if this Agreement had been executed with the invalid provision(s) eliminated.
- 8. This Agreement and the rights and obligations of the parties hereunder shall be construed in accordance with, and governed by, the laws and regulations of the State of New York and applicable Federal laws and regulations.
- 9. Both parties represent and warrant: (a) that the party has no obligations, legal or otherwise, inconsistent with the terms of this Agreement; (b) that the performance of the Services to be provided in this Agreement does not and will not violate any applicable law, rule or regulation or any proprietary or other right of any third party; and (c) that the party has not entered into or will not enter into any Agreement (whether oral or written) in conflict with this Agreement.
- 10. This Agreement is the complete and exclusive statement of the Agreement between the parties, and supersedes all prior or contemporaneous, oral or written: agreements, proposals, understandings, representations, conditions or covenants between the parties relating to the subject matter of the Agreement.
- 11. This Agreement may not be changed orally, but only by an Agreement, in writing, signed by authorized representatives of both parties.
- 12. This Agreement is made for the benefit of the parties, and is not intended to benefit any third party or be enforceable by any third party.
- 13. The parties to this Agreement are independent contractors. Neither party shall have the right or authority or shall hold itself out to have the right or authority to bind the other party, nor shall either party be responsible for the acts or omissions of the other.
- 14. The undersigned representative of Participating Charter School hereby represents and warrants that the undersigned is an officer, director, or agent of Particapating Charter School with full legal rights, power and authority to enter into this Agreement on behalf of Particapating Charter School and bind Particapting Charter School with respect to the obligations enforceable against Particapting Charter School in accordance with its terms.

- 15. Any dispute arising under this Agreement shall be litigated in the Courts of Suffolk County, New York.
- 16. This Agreement, and any amendments to this Agreement, will not be in effect until agreed to in writing and signed by authorized representatives of both parties.
- 17. This Agreement has been arrived at mutually and is not to be construed against any party hereto as being the drafter hereof or causing the same to be drafted.

The participant identified below as the Participating Charter School desires to participate in the Agreement and by signing below hereby demonstrates Participating Charter School's intent to be bound by the Terms and Conditions of the Agreement which consists of the attached NYC Charter Schools Data Services Agreement, Schedule A, Contact Information, and Schedule B, Description of Services and Fee Schedule.

Participating Charter School represents and warrants (a) that it has the requisite authority to execute this Agreement to Terms and Conditions; and (b) that the individual signing this Agreement to Terms and Conditions on behalf of Participating Charter School is authorized to do so. Participating Charter School may and hereby does bind itself to the terms and conditions of the Agreement, including without limitation, the attached NYC Charter Schools Data Services Agreement Authorization, NYC Charter Schools Data Services Agreement, Schedule A, Contact Information, and Schedule B, Description of Services and Fee Schedule.

Participating Charter School understands and acknowledges that the Agreement is not binding unless it is accompanied by an executed NYC Charter Schools Data Services Agreement Authorization and an ESBOCES representative signs below.

SCHEDULE B

DESCRIPTION OF DATA PROCESSING SERVICES and FEE SCHEDULE

DESCRIPTION OF DATA PROCESSING SERVICES:

Attendance APP – This optional application allows a Participating Charter School to report student daily attendance data as required by the New York State Department of Education (NYSED). This Application, developed and owned by Eastern Suffolk BOCES, assists with compliance for complete Attendance reporting through the evaluation of large quantities of incomplete or missing data that is required for reporting purposes in New York State. The Attendance App utilizes data from multiple available data sets and then, using that data, will allow the user to auto-populate and assign all targeted fields with the predominate attendance code to all enrolled students on a given date/date range. The user will then only need to edit individual records for students with any alternate attendance code.

The average attendance rate in NYS in 94%; the App will allow for "generic" assignments of default data and minimize the work, effort and time and record exact data for records student absences. The Attendance App is designed as a cost-effective solution to provide the participating Charter school with the ability to create electronic records in the NYSED required format in the absence of a costly student management system. Participating Charter Schools are responsible for reviewing all attendance data in Level 0 for accuracy and must ensure that the data prep process in Level 0 has been completed in order for their data to be successfully transferred onward in the data warehouse for submission to NYSED. ESBOCES' Attendance App offers NYC charter schools a method to meet the Annual NYSED Accountability reporting requirements in the Student Information and Repository System.

Attendance APP Data Processing Services— The ESBOCES RIC will grant access to the Attendance App for a Participating Charter School for the duration of the agreed upon term. During this term the Participating Charter School will be able to modify attendance data for a maximum window of any two consecutive months, at any given time. The APP's ability to automate the creation of missing data will save them time and money. Each Participating Charter School will be REQUIRED to adjust ALL attendance records for each student to accurately reflect their students' attendance data. As the Participating Charter School determines that each month's data is complete, they will Export a specified month's data, at which time the application will transfer the data to Level 0 for auto-import. Final data verification must be completed utilizing the NYSED Level 2 Reporting environment, L2RPT. ALL corrections must be made in Level 0 prior to the close of the data warehouse in July of each year.

FEE SCHEDULE:

All subscriptions allow for the reporting of SDA data for the entire school year regardless of subscription date. Pricing will not be pro-rated.

Per student fees are calculated based on BEDS Day enrollment and are not subject to flucutations in actual student enrollment throughout the school the year.

The Attendance App will process daily attendance data based on every student's unique enrollment regardless of the student's enrollment on BEDS Day. BEDS Day enrollment will be calculated by ESBOCES based on ATS infromation provided by the NYCDOE in stored in our data warehouse on October 31 of each year. This number may vary from the final BEDS Day count calculated by NYSED.

All subscriptions purchased between July 1 and October 31 shall result in two (2) separate bills being submitted to the participating charter school: the Software Subscription/License fee will be billed immediately following the request for the services, and the Per Pupil Record Management fee will be billed within thirty (30) days of October 31. Payment is due within ten (10) days of receipt.

All subscritions purchased after October 31 shall result in one (1) bill for the total amount due and payment is due within ten (10) days of receipt.

DATA PROCESSING -- MANAGEMENT SYSTEM SUPPORT SERVICE:

<u>Student Management Systems (SMS) Support</u> – This optional service allows a Participating Charter School to access training, customer service supports and the service of data extracts and imports automation to Level 0. These services are specific to the functionality and capabilities of the school's SMS. These services will focus on the set-up and maintenance of the SMS for data management.

Eastern Suffolk BOCES provides school districts and charter schools across the state with training materials and in-person/virtual training events with regards to best practices and the usage of any one of the four major student management systems. This SMS support service entitles the school to annual training events, user group meetings, and unlimited ad hoc access to a specialist via help desk tickets/emails and calls. Services will include the standard functionality of the SMS software's capabilities for master scheduling, attendance, state reports, parent portal, disciplinary tracking, teacher gradebooks, report cards, and other standard functionalities.

This service also provides a Secure File Transfer Protocol (SFTP) account on the ESBOCES network for the school/network's SMS. Support and maintenance for the setup of the SMS/s capability to automate the process of data exports being posted to the SFTP. Support is also included for the monitoring of loaded data accomplished via automatic transfer for the files to the NYC Level 0 software. We will outline aggregate summary information regarding the processing of each auto-transfer and generate a receipt of transfers that will be emailed to the school's authorized Level 0 users.

Schools needing individualized supports, such as for the transition to a new SMS or implementing best practices for the utilization of the software's capabilities may wish to purchase additional services. Based on availability and aligned to the school's needs, virtual and/or on-site (at your charter school) custom services are available for the creation of custom reports, consultation or training for individuals or all staff: hourly or daily, with discounted pricing for supports running over five or more days.

Fee Schedule:

A subscription to the SMS support services includes techincal support for all of the standard SMS features and an SFTP for automated transfers. Services starting after July 1 of any school year will be prorated based one the designated support start date and the number of days remaining in the school year. Per student fees are calculated based on BEDS Day enrollment data. Annual BEDS Day data is published by NYSED in January of each year.

Billing Quarters 1 & 2: Purchases made prior to the publication of the BEDS Day data for the current school year will be estimated and billed during the first two quarters using the SIRS 313: BEDS Day enrollments report from the prior school year. New schools will not have a BEDS 313

report: ESBOCES will calculate the cost based on the expected enrollment as provided by the school.

Billing Quarters 3 & 4: Current year enrollment data will then be reviewed in January. Any price adjustments will be applied for the 3rd and 4th quarters based on actual enrollment. Credits or increased cost will be reflected evenly across the final invoices.
