What if my school has missed the initial data pull of Out of Certification (OOC)?

SED will be sending out reminders to schools that are missing this data in Level 2 of SIRS/data warehouse. Continue to report this data at your earliest convenience. Verify the accuracy of staff reporting in <u>L2RPT</u> with the SIRS 328, Out of Certification Verification Report. ALL corrections MUST be made in Level 0.

Your school is expected to verify reporting of all data to NYSED via the corresponding SIRS report(s) in L2RPT. Any errors in the associated SIRS report must be corrected in Level 0. FYI- any OOC related template with an error in Level 0 will prevent the data from transferring to NYSED. Call us if you need help: 631.218.4134.

Student Digital Resources (SDR)

The annual collection of this data is a Level 0 reporting requirement aligned to the regulations of the US Department of Education. Each school is expected to annually survey families for each student's access to devices and internet service in their place of residence. ESBOCES manages the reporting of this data in Level 0 on behalf of the NYSDOE. Each school is responsible for the actual survey.

As per the SIRS Annual Reporting Timeline, SED will start reviewing data in Level 2 of the data warehouse in early February. Leaders of schools missing SDR data in L2RPT are expected to soon receive reminder of this important, federal, data reporting requirement. SDR should be reported/refreshed in Level 0 throughout the remainder of the school year.



Accessing L2RPT is managed by the school CEO

ONLY your school CEO or a Delegated Administrator can authorize anyone to access L2RPT, the Business Portal, or any other NYSED system. ESBOCES, NYCDOE (Charter Schools Office), and NYSED cannot create or manage access to those data systems.

Each school superintendent/CEO, as listed in <u>SEDREF</u>, was given administrative access by default to the SED Delegated Account Systems (SEDDAS). Access to SEDDAS is available within the <u>NYSED Application</u>

<u>Business Portal - Dashboard</u> (must be logged in). Only the CEO, or delegate, can provide access to any SED system for their school to another person. Access will be instantaneous once you are given these permissions. Note that the NYSED Application Business Portal and access to L2RPT, <u>IBM Cognos Analytics</u>, utilize the same credentials.
