L2RPT Access:

ESBOCES, the NYCDOE nor NYSED can provide ANYONE with access to L2RPT or any other SED system (including the Business Portal).

Each school's superintendent/CEO, as listed in <u>SEDREF (nysed.gov)</u>, was given administrative access by default to the SED Delegated Account Systems (SEDDAS). Access to SEDDAS is available within the <u>NYSED Application Business Portal - Dashboard</u> (must be logged in). Only the CEO, or delegate, can provide access to any SED system for their school to another person. Access will be instantaneous once you are given these permissions. Please Note: The NYSED Application Business Portal and access to L2RPT, <u>IBM Cognos Analytics (nycenet.edu)</u>, utilize the same credentials.
